1. Background

The EGCC Board is seeking submissions on its proposals to amend the Scheme document to:

- Allow the Commissioner to consider complaints about bottled LPG
- Allow the Board to appoint an acting Chair when the Chair is unavailable
- Make other minor changes to clarify certain issues

This consultation document sets out the timetable, summarises the proposed changes, and provides information on the submission process.

2. Process and proposed timetable

The Board will appoint a working group of stakeholder representatives to review submissions received and make recommendations to the Board. The Board will seek nominations to the working group separately from this consultation document.

6.1. Remove exclusion for complaints about bottled LPG

Table 2 summarises the proposed changes to the Scheme to remove the exclusion for complaints about bottled LPG.

6.2. Board to appoint an acting Chair when the Chair is unavailable

The Board proposes to amend the Scheme to allow the Board to appoint one of the consumer representatives as an acting Chair when the Chair is unavailable. This is to allow uninterrupted governance of the Scheme, and to mitigate the risk from the Chair being unavailable.

The Board of the Scheme is comprised of two member representatives, two persons appointed by the Minister of Consumer Affairs (consumer representatives), and an independent Chair. The required quorum for Board meetings is four Board members, including the Chair. There is not provision for the appointment of an acting Chair, should the Chair be unavailable.

The recommended change is to allow four members of the Board, present at a meeting for which the Chair is unavailable, to appoint one of the consumer representatives as the Acting chair. The reason the Acting Chair is limited to one of the two consumer representatives is to ensure the governance of the Scheme remains independent of the industry.²

The reworded clause says:

6.3. Other minor changes to clarify certain clauses

The Board proposes other minor changes to the Scheme to clarify certain clauses. Table 3 summarises these proposed changes.
